

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Nueva Ecija University of Science and Technology through the Bids and Awards Committee (BAC) invites Contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bid for hereunder contract

Name of Project : Proposed Two-Storey athlete's quarter/hostel extension

Location: NEUST Main Campus, Sumacab Este, Cabanatuan City
Approved Budget for the Contract (ABC): PhP 4,999,963.82
Contract Duration: 150 Calendar Days
Source of Fund: IGP Fund

Prospective bidder should possess a valid PCAB license applicable to the contract, have completed a similar contract with the value of at least 50 % of the ABC, and have key personnel and equipment (Listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post qualification of the lowest calculated bid.

All particulars to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the results of the Eligibility Check by the BAC at the same address.

The BAC will issue bidding documents only to bidders declared by the BAC to be eligible for the bidding upon payment of the non-refundable amount of:

PhP 5,000.00 for the Proposed Two-Storey athlete's quarter/hostel extension

to the Nueva Ecija University of Science and Technology Cashier Office.
