

INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The Nueva Ecija University of Science and Technology through the Bids and Awards Committee (BAC) invites bidders to apply for eligibility and to bid for hereunder Projects.

Name of Project: SUBSCRIPTION OF NEWSPAPER

Location: NEUST All Campuses except San Isidro and Gabaldon Campuses
Approved Budget for the Contract (ABC): Prevailing Rates of Newspaper
Contract Duration: June 1, 2014 to May 31, 2015
Fund Source: GENERAL FUND

Prospective bidder should have completed a similar contract with the value of at least 50 % of the ABC, and have key personnel and equipment (Listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post qualification of the lowest calculated bid.

All particulars to the Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

Prospective bidders shall submit the Eligibility Requirements to the BAC at the said address. They may also obtain the results of the Eligibility Check by the BAC at the same address.
