KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT OF SERVICE is entered into by and between:

The NUEVA ECIJA UNIVERSITY OF SCIENCE AND TECHNOLOGY, Cabanatuan City, represented by its President, DR. FELICIANA P. JACOBA of legal age, married, Filipino and with office address at Gen. Tinio St., Cabanatuan City hereinafter referred to as the PARTY OF THE FIRST PART;

ICOR ENTERPRISES, a printing press registered in accordance with law, herein represented by its proprietor MR. IRENEO L. ICO, also of legal age, Filipino and with office address at Tuliao, Sta. Barbara, Pangasinan, hereinafter referred to as the PARTY OF THE SECOND PART.

WITNESSETH

- That the PARTY OF THE FIRST PART is in need of the services of the PARTY OF THE SECOND PART which shall undertake the supply and delivery of the project PRINTING OF YEARBOOK 2017 (3, 650 COPIES);
- That the PARTY OF THE SECOND PART shall provide the PARTY OF THE FIRST PART, the supply and delivery of PRINTING OF YEARBOOK 2017 (3, 650 COPIES);
- 3. That the PARTY OF THE FIRST PART shall pay the PARTY OF THE SECOND PART the amount of ONE MILLION SEVEN HUNDRED FORTY NINE THOUSAND THREE HUNDRED THIRTY FIVE PESOS AND FIFTY CENTAVOS ONLY (Php 1, 749, 335.50) for the supply and delivery of PRINTING OF YEARBOOK 2017 (3, 650 COPIES):

- 4. That the PARTY OF THE SECOND PART shall immediately perform its obligation within forty five (45) calendar days from the time of the receipt of the APPROVED FINAL DRAFT from the end user:
- 5. That the following documents shall be deemed to form and be read and construed as part of this agreement, viz.:
 - a. The bid forms or quotation and the price schedule submitted by the bidder;
 - b. The Technical Specifications;
 - c. The General and Special Conditions of the Contract;
 - d. The notice of award; and
 - e. The notice to proceed
- 6. That the PARTY OF THE FIRST PART shall have the right to withhold payment to the PARTY OF THE SECOND PART and/or to proceed against or collect from the performance security, at the option of the PARTY OF THE FIRST PART to cover the liability of the PARTY OF THE SECOND PART in case of any breach of any of its obligations under this Agreement; provided that this shall be without prejudice to other courses of action that the PARTY OF THE FIRST PART may take against then PARTY OF THE SECOND PART under the circumstances;
