

CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT OF SERVICE** is entered into by and between:

The **NUEVA ECIJA UNIVERSITY OF SCIENCE AND TECHNOLOGY**, Cabanatuan City, represented by its President ENGR. FELICIANA P. JACOBA of legal age, married, Filipino and a resident of General Tinio St., Cabanatuan City hereinafter referred to as the **PARTY OF THE FIRST PART**;

-And-

ACCUPROF LABORATORY AND DIAGNOSTIC, an entity accredited by the Department of Health (DOH) engaged in the delivery and performance of medical laboratory and diagnostic work represented by its proprietor, MS. SHARON D. CHUA, also of legal age, Filipino and with office address at Old Wesleyan Bldg., Quimson corner Mabini St., Brgy. Quezon District, Cabanatuan City, Philippines, hereinafter referred to as the **PARTY OF THE SECOND PART**.

WITNESSETH:

1. That the **PARTY OF THE FIRST PART** is in need of the services of the **PARTY OF THE SECOND PART** which shall undertake the performance and delivery of **MEDICAL LABORATORY EXAMINATION FOR FRESHMEN STUDENTS**;
2. That the **PARTY OF THE SECOND PART** shall provide the **PARTY OF THE FIRST PART** the performance and delivery of **MEDICAL LABORATORY EXAMINATION FOR FRESHMEN STUDENTS**;
3. That the **PARTY OF THE FIRST PART** shall pay the **PARTY OF THE SECOND PART** the amount of **ONE MILLION FIVE HUNDRED TEN THOUSAND SEVEN HUNDRED PESOS ONLY (Php 1, 510, 700.00)** for the

supply and delivery of the project **MEDICAL LABORATORY EXAMINATION FOR FRESHMEN STUDENTS;**

4. That the PARTY OF THE SECOND PART shall immediately perform its obligation within sixty (60) working days from the time of the receipt of the Notice to Proceed;
5. That the following documents shall be deemed to form and be read and construed as part of this agreement, viz.:
 - a. The bid forms or quotation and the price schedule submitted by the bidder;
 - b. The Technical Specifications;
 - c. The General and Special Conditions of the Contract;
 - d. The notice of award; and
 - e. The notice to proceed
6. That the PARTY OF THE SECOND PART shall also guarantee to the PARTY OF THE FIRST PART that the **MEDICAL LABORATORY EXAMINATION FOR FRESHMEN STUDENTS** shall be free from any disease contagious or otherwise and the highest degree of sanitation shall be strictly observed;

That the PARTY OF THE FIRST PART shall have the right to withhold payment to the PARTY OF THE FIRST PART and/or to proceed against or collect from the performance security, at the option of the PARTY OF THE FIRST PART to cover the liability of the PARTY OF THE FIRST PART in case of any breach of any of its obligations under this Agreement; provided that this shall be without prejudice to other courses of action that the PARTY OF THE FIRST PART may take against then PARTY OF THE SECOND PART under the circumstances;




