This CONTRACT made and entered into this 25th day of September, 2018 by and between:

ENGR. DEAN A. CANCINO, President/CEO of DACWORKS UNITED, INC., a duly registered and licensed contractor with postal address at 516 Cordillera Street, Highway Hills, Mandaluyong City hereinafter called as the Party of the Second Part.

WHEREAS, the Owner/Party of the First Part is desirous that certain works should be constructed particularly at the NUEVA ECIJA UNIVERSITY OF SCIENCE AND TECHNOLOGY, Cabanatuan City and has accepted the bid of the Contractor/Party of the Second Part for the PROPOSED INSTALLATION OF CENTRAL SPLIT-TYPE AIRCONDITIONING SYSTEM WITH PRE-COOLER SYSTEM INCLUDING TESTING AND COMMISSIONING located at University Closed Gymnasium, NEUST Sumacab Campus, Cabanatuan City in the amount of SEVENTEEN MILLION THREE HUNDRED THIRTY ONE THOUSAND FIVE HUNDRED EIGHTY NINE PESOS AND 74/100 (Php 17,331,589.74) Philippine Currency, in accordance with the provisions of the bidding documents with the following major scope of work, to wit:

PROPOSED INSTALLATION OF CENTRAL SPLIT-TYPE AIRCONDITIONING SYSTEM WITH PRE-COOLER SYSTEM INCLUDING TESTING AND

Location:

University Closed Gymnasium, NEUST Sumacab Campus, Cabanatuan City

Scope of Work:

- 1. Provision of central split-type airconditioning units.
- 2. Installation of pipes, fittings and air ducts.
- Provision of hanger/supports/platform.
- Installation of electrical wirings and conduits.
- 5. Testing and commissioning.

This Contract witnesseth as follows:

- In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to:
- II. That the following documents shall be deemed to form and be interpreted and constructed as part of the Contract, viz:
 - a. General and Special Conditions of Contract;
 - b. Drawings/Plans;
 - c. Specifications;
 - d. Invitation to Apply for Eligibility and to Bid;
 - e. Bidding Documents;
 - f. Addenda and/or Supplemental/Bid Bulletins, if any;
 - g. Bid form, including all the documents/statements contained in the Bidder envelopes, as annexes;

- Performance Security;
- Notice of Award of Contract and winning Bidder's "Conforme" thereto; and.
- k. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Bidding Documents, such as the construction schedule and S-curve, manpower schedule, construction methods, equipment utilization schedule, construction safety and health program approved by DOLE and PERT/CPM.
- III. In consideration of the payments to be made by the Party of the First Part to the Party of the Second Part, hereinafter mentioned as Contractor hereby covenants with the Party of the First Part of PROPOSED INSTALLATION OF CENTRAL SPLIT-TYPE AIRCONDITIONING SYSTEM WITH PRE-COOLER SYSTEM INCLUDING TESTING AND COMMISSIONING;
- IV. That the Party of the Second Part shall furnish with his own funds all labor, materials and equipment and other plans necessary for the complete accomplishment of the aforesaid project and shall be primarily responsible in the acquisition of all permits and other documents necessary prior to actual work;
- V. The Party of the Second Part shall execute a Bid Securing Declaration intended primarily to guarantee the full and faithful compliance of its obligation to the Party of the First Part of the contract, including payment of wages and materials, allowances and other claims that arise out of the contract as fully completed in accordance with the approved plans, specifications and Program of Work of the project;
- VI. The Party of the Second Part shall complete PROPOSED INSTALLATION OF CENTRAL SPLIT-TYPE AIRCONDITIONING SYSTEM WITH PRE-COOLER SYSTEM INCLUDING TESTING AND COMMISSIONING located at University Closed Gymnasium, NEUST Sumacab Campus, Cabanatuan City as herein described within ONE HUNDREED FIFTY (150) CALENDAR DAYS from the effective date that the Party of the First Part shall have notified the Party of the Second Part in writing to commence the construction work unless no additional time is given the Party of the Second Part in writing;

That the Party of the Second Part, in case of delay in the prosecution of the project, shall be liable to the Party of the First Part as liquidated damages at the rate of 0.1% applicable to the total contract cost less value of usable portion of the project per day of delay beyond the contract expiry date;

That the Party of the First Part hereby covenants to pay the Party of the Second Part in consideration for the PROPOSED INSTALLATION OF CENTRAL SPLITTYPE AIRCONDITIONING SYSTEM WITH PRE-COOLER SYSTEM INCLUDING TESTING AND COMMISSIONING located at University Closed Gymnasium, NEUST Sumacab Campus, Cabanatuan City in the amount of SEVENTEEN MILLION THREE HUNDRED THIRTY ONE THOUSAND FIVE HUNDRED EIGHTY NINE PESOS AND 74/100 (Php 17,331,589.74) Philippine Currency;
- IX. The Party of the Second Part warrants that he has not given nor promised to give money or gifts of any kind to any employee of the Party of the First Part to secure this contract;
- X. That the Party of the First Part reserves the right to terminate and/or rescind this Contract in case the Party of the Second Part violates any of the terms and conditions herein set forth and, that finally;

- XIII. The Party of the Second Part shall comply with the strict observance of all laws regarding workmen's health, safety, workmen's welfare, compensation for injuries, minimum wages, hours of labor and other labor laws.
