



KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT OF SERVICE is entered into by and between:

The **NUEVA ECIJA UNIVERSITY OF SCIENCE AND TECHNOLOGY**,
Cabanatuan City, represented by its President ENGR. FELICIANA P. JACOBA
of legal age, married, Filipino and a resident of General Tinio St., Cabanatuan
City hereinafter referred to as the PARTY OF THE FIRST PART;

NUJNUJ FOODS CORPORATION, a corporation engaged in restaurant
and catering services represented by its President, MR. RAYMUNDO M. CRUZ,
JR., also of legal age, Filipino and with office address at 039 Gen. Luna Street,
Cabanatuan City, hereinafter referred to as the PARTY OF THE SECOND PART.

- W I T N E S S E T H -

1. That the PARTY OF THE FIRST PART is in need of the services of the PARTY OF THE SECOND PART which shall undertake the project CATERING SERVICES FOR SK TRAINING at the various campuses of NEUST;
2. That the PARTY OF THE SECOND PART shall provide the PARTY OF THE FIRST PART, the supply and delivery of CATERING SERVICES FOR THE SK TRAINING at the various campuses of NEUST;
3. That the PARTY OF THE FIRST PART shall pay the PARTY OF THE SECOND PART the amount of **ONE MILLION NINETY NINE THOUSAND PESOS ONLY (Php 1, 099, 000.00)** for the supply and

delivery of the project CATERING SERVICES FOR THE MONTH OF AUGUST 2018 at the NEUST Sumacab Campus;

4. That the PARTY OF THE SECOND PART shall immediately perform its obligation from the time of the receipt of the Notice to Proceed as indicated in the Invitation to Bid;
5. That the following documents shall be deemed to form and be read and construed as part of this agreement, viz.:
 - a. The bid forms or quotation and the price schedule submitted by the bidder;
 - b. The Food Menu and Schedule of Servings;
 - c. The General and Special Conditions of the Contract;
 - d. The notice of award; and
 - e. The notice to proceed
6. That the PARTY OF THE FIRST PART shall have the right to withhold payment to the PARTY OF THE SECOND PART and/or to proceed against or collect from the performance security, at the option of the PARTY OF THE FIRST PART to cover the liability of the PARTY OF THE SECOND PART in case of any breach of any of its obligations under this Agreement; provided that this shall be without prejudice to other courses of action that the PARTY OF THE FIRST PART may take against then PARTY OF THE SECOND PART under the circumstances;
7. The PARTY OF THE FIRST PART reserves the right to withdraw the award from the PARTY OF THE SECOND PART should it become apparent after the award that the latter does not possess sufficient technical knowledge, expertise and capacity to comply with its obligations;
8. That the PARTY OF THE SECOND PART guarantees the PARTY OF THE FIRST PART the exclusive right to refund any payment made by the latter to the former in the event that the specifications required by

the PARTY OF THE FIRST PART and agreed upon by both parties are not complied with;




