



CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT OF SERVICE is entered into by and between:

The NUEVA ECIJA UNIVERSITY OF SCIENCE AND TECHNOLOGY, Cabanatuan City, represented by its President, ENGR. FELICIANA P. JACOBA of legal age, married, Filipino and a resident of General Tinio St., Cabanatuan City hereinafter referred to as the PARTY OF THE FIRST PART;

-And-

JBDC OCCUPATIONAL HEALTH SAFETY AND ENVIRONMENT CONSULTANCY, a company engaged in the supply and delivery of professional services in the area of Project Management, ISO Certification, Inspection and Testing of Lifting Equipment, and HSSEQ Competency Trainings, represented by its Attorney-in-Fact, JOY T. GARCIA, also of legal age, Filipino, and a resident of Masalasa, Victoria, Tarlac, hereinafter referred to as the PARTY OF THE SECOND PART.

WITNESSETH

1. That the PARTY OF THE FIRST PART is in need of the services of the PARTY OF THE SECOND PART which shall undertake the supply and delivery of the project CONSULTANCY SERVICES: 2015 QUALITY MANAGEMENT SYSTEMS FOR ALL NEUST CAMPUSES;
2. That the PARTY OF THE SECOND PART shall provide the PARTY OF THE FIRST PART, CONSULTANCY SERVICES: 2015 QUALITY MANAGEMENT SYSTEMS FOR ALL NEUST CAMPUSES;

3. That the PARTY OF THE FIRST PART shall pay the PARTY OF THE SECOND PART the amount of THREE HUNDRED FIFTY THOUSAND PESOS ONLY (Php 350, 000.00), for the supply and delivery of the project CONSULTANCY SERVICES: 2015 QUALITY MANAGEMENT SYSTEMS FOR ALL NEUST CAMPUSES;
4. That the PARTY OF THE SECOND PART shall perform work within a period of thirty five (35) calendar days from the time of the receipt of the Notice to Proceed, as indicated in the Invitation to Bid;
5. The following documents shall be deemed to form and be read and construed as part of this agreement, viz.:
 - a) The Bid Form and the Price Schedule submitted by the bidder;
 - b) The Technical Specifications;
 - c) The General and Special Conditions of the Contract;
 - d) The Notice of Award; and
 - e) The Notice to Proceed.
6. That the PROJECT PROPOSAL containing the TERMS OF REFERENCE of the CONSULTANCY SERVICES: 2015 QUALITY MANAGEMENT SYSTEMS (attached herewith) shall form part of this Contract;
7. That the PARTY OF THE FIRST PART shall have the right to withhold payment to the PARTY OF THE SECOND PART and/or to proceed against/collect from the Performance Security, at the option of the PARTY OF THE FIRST PART, to cover the liability of the PARTY OF THE SECOND PART; Provided that this shall be without prejudice to other courses of action that the PARTY OF THE FIRST PART may take against the PARTY OF THE SECOND PART under the circumstances;
8. The PARTY OF THE FIRST PART reserves the right to withdraw the award from the PARTY OF THE SECOND PART should it become apparent after the award that the latter does not possess sufficient technical knowledge, expertise and capacity to comply with its obligations;

9. That the PARTY OF THE SECOND PART guarantees the PARTY OF THE FIRST PART the exclusive right to refund any payment made by the latter to the former in the event that the specifications required by the PARTY OF THE FIRST PART and agreed upon by both parties are not complied with;

10. That all actions arising from breach or violation of any of the provisions of this Contract shall be filed solely and exclusively in the proper court of the City of Cabanatuan and to the exclusion of all others.


