- 3. All quotations shall be considered as fixed prices and not subject to price escalation during contract implementation.
- 4. The Request for Quotation (RFQ) form must be accompanied with program of works and detailed
- 5. Any erasures or overwriting shall be valid only if they are signed or initialed by the Contractor or his/her authorized representative.

The BAC is conducting Alternative Mode of Procurement (Small Value Procurement) for this Contract in accordance with RA 9184 and Its Implementing Rules and Regulations (IRR).

Prospective bidder/contractor shall be a duly licensed Filipino citizen/sole proprietorship, partnership, corporation, cooperative duly organized under the laws of the Philippines with at least seventy five percent (75%) interest or outstanding capital stock belongs to citizens of the Philippines.
