- 3. All quotations shall be considered as fixed prices and not subject to price escalation during contract implementation.

The BAC is conducting Alternative Mode of Procurement (Small Value Procurement) for this Contract in accordance with RA 9184 and Its Implementing Rules and Regulations (IRR).

Prospective bidder/contractor shall be a duly licensed Filipino citizen/sole proprietorship, partnership, corporation, cooperative duly organized under the laws of the Philippines with at least seventy five percent (75%) interest or outstanding capital stock belongs to citizens of the Philippines.

The participating bidder/contractor should have completed a similar project with the value of at least 50% of the ABC, and have key personnel and equipment available for the prosecution of the contract.
