  - Certified True Copy of Valid Mayor's/Business Permit
  - Certified True Copy of Valid PhilGEPs Certificate of Registration
  - Certified True Copy of Valid PCAB License applicable to the type and cost of the contract
  - Certified True Copy of Valid BIR Certificate of Registration
  - Certified True Copy of Updated Income Tax Return (stamped "received" by the BIR)
  - Notarized Omnibus Sworn Statement
  - Official Receipt (O.R.) of payment of Bidding Documents
3. All quotations shall be considered as fixed prices and not subject to price escalation during contract implementation.
4. The Request for Quotation (RFQ) form must be accompanied with Program of Works and Detailed Estimates.
5. Any erasures or overwriting shall be valid only if they are signed or initialed by the Owner or his/her Authorized Representative.
6. Quotations exceeding the Approved Budget for the Contract (ABC) shall be rejected.
7. Notarized Special Power of Attorney (SPA or Secretary's Certificate) shall be submitted if the person is an authorized representative. To be presented to the BAC-SECRETARIAT upon submission of the RFQ.
